<b>Plaza's of Multan Having Play Lands</b>	<ul style="list-style-type: none"> <li>• Visit of all Plaza's having play areas to prohibit them regarding use of any swing or activities which could be risky.</li> <li>• Assurance on prohibition of parties on roof top of Plaza's regarding Good Friday or Easter celebrations.</li> </ul>	➤ Addl. D.G MDA
<b>Intimation of Good Friday or Easter Programs</b>	<ul style="list-style-type: none"> <li>• In time intimation to concerned departments regarding any programs of Good Friday or Easter in the any educational institute of Multan.</li> </ul>	➤ CEO, DEA
<b>Permission of Any Good Friday or Easter Programs by the NGOs</b>	<ul style="list-style-type: none"> <li>• Intimation and permission of Good Friday or Easter arranged by any NGO in the District before time to and from the concerned departments.</li> </ul>	➤ SWO, Social Welfare Multan
